Resolution 2: Election of Dr BIHOLONG into the position of Treasurer of the Council.

Following a motion submitted to the President of the CMC by 10 out of 12 Council members

relating to the loss of confidence in the Treasurer Pr Kandem Félicité, a vote of non confidence was passed and within the Council voting took place, as previewed by our texts, and Dr BIHOLONG was unanimously voted into the position of Treasurer by 10 out of 12 Members with 2 abstentions.

Resolution 3: Organization of an ExtraOrdinary General Assembly in 3 months, March 2024, dedicated specifically to the Unemployment of Young Doctors

Resolution 4: Meeting with the ORDER OF PHARMACISTS in January 2024 for the creation of a permanent communication platform

<u>Resolution 5</u>: Encouragement of the creation of Professional civil societies to resolve the unemployment of Young doctors



Resolution 6: Meeting with the Minister of Communication for information related to the fight of illegal Medical practice.

Resolution 7: Holding of Council sessions every two months accompanied by vulgarisation of the CMC texts.

Resolution 8: Advocacy for the re-evaluation of medical procedures and the codification of new procedures.

Resolution 9: Propose to the Extraordinary General Assembly in March to give discounts on arrears of Annual contributions.

<u>Resolution 10</u>: Request for Registration into the CMC, Private Practice authorization and request for change of geographical area

- 113 applications were received at the headquarters of the Council in Douala and Yaounde as follows:
- 96 application files for registration into the roll of Doctors
- 16 application files for Private Practise Authorization
- 1 request file for change of geographical area of Practice

After examination, applications that were unanimously Approved by the Council:

- 66 Applications for Registration into CMC
- 12 applications for Private Practice Authorization.
- 1 request application change of geographical area.

Files rejected by the Council:

- 30 application for Registration
- 4 Applications for Private Practise Authorization
- 1 application for change of geographical area.

• All these files were rejected for non-compliance. Mandate is given to the Secretary General of the Council to invite each applicant to regularize their file in view of a re-examination at the next session of the Council session.

#### **Financial Resolutions:**

- > For the Security of CMC bank accounts, there will be the establishment of a platform preceded by wide dissemination to doctors for electronic payments
- Reduction of the CMC accounts from 6 to 3.
- > Inform doctors of the creation of a platform for electronic payment
